### **Remote Express — Fast, Secure Re-registration from Your Phone**

Remote Express lets eligible registrants complete required registrations and updates quickly from a smartphone — anytime, anywhere. It's simple, secure, and designed to save you time, travel costs, and the hassle of waiting in a crowded office.

#### **Why sign up?**

- **No office visit required\***. Update addresses, phones, vehicles, scars/marks/tattoos and more without coming in — all from your phone.
- **Fast results**. Officers review submissions electronically and will approve, request clarification, or notify you if an in-person visit is needed. You get SMS and email updates so you always know the outcome.
- **Built for accuracy**. Upload photos of yourself, vehicles and tattoos to reduce errors and speed approval. Vehicle updates require a photo of the vehicle and its registration.
- **Secure identity checks**. Sign in with a live selfie (anti-spoofing checks and officer verification), provide location, attest to required laws, and sign electronically — all to protect the integrity of your submission.
- **Convenient payment**. A single yearly subscription lets you use the app; payment is handled securely in the app. (Fee and payment options are set by your agency.)

#### **Quick steps to get started**

1. Ask your agency to enable Remote Express for you.
2. Go to **remote-express.offenderwatch.com (or scan qr code on the back page)** and log in with your name, DOB, last 4 of SSN, and state.
3. Take the requested selfie, allow location, complete updates, review attestations, sign, and submit.

**\*One important note:** Agencies decide who may use Remote Express and can still require you to appear in person if what you submit as information is rejected as questions remain. Remote Express speeds the process for eligible users but does not replace agency authority.

## IF YOUR AGENCY HAS 'ENABLED YOU' for REMOTE EXPRESS

Prior to any electronic submission through the Remote Express application, the registrant must provide the following clear, affirmative consents:

a. **Biometric Consent:** consent to the collection and use of the offender's facial image and biometric template for identity verification only, as described above. The offender understands the biometric data will be used solely for verification and will be retained and protected as described in the Agency's privacy practices.

b. **Location Consent:** The offender must consent to the capture of GPS geocoordinates when they submit their registration information.

c. **Signature Consent:** The offender documents their consent with their electronic signature as a legal signature and attestation to the truth and completeness of the information the offender submits.

d. **Notification Consent:** The offender agrees to receive communications related to their information update submission by SMS text message and email.

e. **Photo & Evidence Consent:** Offenders will consent to the capture and use of photographs I provide (for myself, vehicles, scars/marks/tattoos) for the purpose of updating their official registration record.
